Releasor, being of lawful age, (or, in the case of a minor, through his/her parent or guardian) in consideration of being permitted to participate in various shooting disciplines and activities at the **Releasees** Facility, either as a member or guest, do for myself, my spouse, legal representatives, heirs, assigns and subrogors, hereby release, waive and forever discharge **Releasees** from any and all liability for any and all losses and damages of any type or kind, and from any and all claims, suits, demands, actions or rights of actions, of whatever kind, either in law or equity, arising from or by reason of death, personal injury known or unknown, or property damage resulting from any incident which may occur during **Releasor's** presence at the **Releasees** Facility, and/or participation in any activity, whether caused in whole or in part by the **Releasees** or any other person or thing at the host while **Releasor** is present. **Releasor**, and his/her parent or guardian in the event **Releasor** is a minor, agree to fully indemnify, defend, and hold **Releasees** harmless for all **Releasor's** actions or omissions while at the host. There is no limit to this indemnity. **Releasor** assumes full responsibility for the risk of bodily injury, death, or property damage due to the negligence of the **Releasees** or any other third party or thing while at the **Releasees** Facility, and while competing, officiating, working, spectating, or for any purpose at the Releasees Facility.

Releasor fully and completely releases the **Releasees** and any of its related parties to and from all liability to **Releasor** and to anyone or any entity claiming by, through or under **Releasor**, by subrogation or otherwise, it being **Releasor's** intent to fully waive and release all subrogation rights.

RELEASOR AGREES THAT THIS RELEASE CONSTITUTES THE ENTIRE AGREEMENT BETWEEN **RELEASOR** AND **RELEASEES** AND THE TERMS OF THIS RELEASE ARE CONTRACTUAL AND NOT A MERE RECITAL, AND THE SAME SHALL CONTINUE IN FULL FORCE AND BE APPLICABLE TO ANY AND ALL ACTIVITIES **RELEASOR** ATTENDS WHILE AT THE **RELEASEES** FACILITY.
